



Americo Annuity Application Bonus DETAILS AND RULES

OVERVIEW

For each LibertyMarkSM or ClassicMarkSM fixed indexed annuity application of \$50,000 or more in premium, earn a \$400 bonus—*OR* a \$500 bonus if you use our FireLight[®] e-app!

ELIGIBILITY

- Applications must be submitted September 1 through December 31, 2018, and be issued and commissions paid by January 31, 2019.
- The Producer must: (1) be the writing agent; (2) be licensed, contracted, and appointed with Americo Financial Life and Annuity Insurance Company to sell LibertyMarkSM and ClassicMarkSM, and be in good standing with Americo and Legacy; and (3) have no outstanding chargebacks, debit balance, or monies owed to Legacy at the close of the qualification period and when any bonus is paid.
- LOAs are eligible; however bonus amounts will be paid to the LOA manager.

PAYMENT

- For eligible applications that are received, issued for at least \$50,000 in premium, and have commissions paid during the qualification period, the writing Producer will receive \$400 plus an extra \$100 if the application is submitted using our FireLight[®] e-app solution.
- Only one bonus will be paid out per client, unless both a qualified and non-qualified application for the same client are submitted.
- If the Producer's commissions are assigned pursuant to an *Assignment of Commissions* form, any bonus amounts will be paid to the assignee, not the writing Producer(s).
- Bonus will be paid approximately 30 days following the date commissions are paid on eligible applications.
- Bonus amounts will be paid as a part of the Producer's commission (commission statement will state "Americo App Bonus" under "client name").

GENERAL GUIDELINES

- Should Legacy Marketing Group[®], Americo, an authorized company, or a policyholder cancel the contract for any reason, the bonus will not be paid on that contract. If a bonus has already been paid, the bonus amount will be charged back.
- All bonus amounts will be reported as income earned in the year distributed, and a 1099 will be issued. We recommend that you consult a tax adviser regarding any tax ramifications.
- This promotion is offered solely by Legacy Marketing Group[®], and Legacy, at its sole discretion, reserves the right to determine participant eligibility and final payment of the bonus, and to revise the guidelines as needed.
